Manager Report: Utility Technician Position Open – Plant Operation Manager, Daryl Back,

and Utility Director, David Beecraft, hosted two interviews last week for

the Utility Technician position.

New Administrative Assistant – We will be welcoming Rebecca Sostenes

as the new Administrative Assistant on May 5th.

Street Sweeping – Street sweeping has started, but then quickly paused. The sweeper is again, broke down. The vacuum is not functioning. We are unfortunately unable to continue sweeping until we find a solution.

Irrigation Systems Startup – The BMMD will begin turning on irrigation meters in the common areas, parks, parkway medians and Tamarisk Village (front yards) between May 1_{st} and May 1_{st} .

GCFMLD Traditional Grant Approval – The BMMD was awarded a \$166,000 grant from the Garfield County Federal Mineral Lease District to rebuild the Water Treatment Plant North Clarifier. The total cost of the project is approximately \$166,970. The BMMD will be contributing approximately an additional amount of \$1,000.

GCFMLD Grant – Sewer Treatment Plant Blower – At last month's Board meeting, Assistant Manager, Alex Morris, updated the Board that administrative staff would be submitting a request to extend the deadline for the completion of the project to December 31, 2025. The FMLD Board accepted the request and gave us a deadline of November 30th, 2025.

Director McElroy made a motion, seconded by Director LeBorgne to approve Resolution 2025-03 for the traditional grant agreement from the Garfield County Federal Mineral Lease District. The motion carried unanimously.
